Transparency International Ireland is developing an executive education programme for business to discuss opportunities to address legal, financial and reputational risks from doing business in countries with weak rule of law.

The risks include:

- > Prosecutions in Ireland for the bribery of foreign public officials overseas
- Prohibition from bidding for any future contracts in the EU if they are found guilty of bribery in the EU
- Seizure of assets proven to have derived from corruption overseas by the Criminal Assets Bureau
- Fall in share price and inability to attract high-calibre staff and investors

Our executive education series will be moderated by experts in the fields of corporate governance and anti-corruption and developed in collaboration with the School of Business, Trinity College Dublin The series is funded by Irish Aid.

Each practical workshop will offer participants an introduction to the knowledge and tools required to make informed choices when working in countries with weak rule of law.
